

PNG COVID-19 Risk Mitigation Training



Under the USAID PEPFAR initiative in PNG, AWR Lloyd and FHI 360 have been engaged to help prevent, detect and respond to the COVID-19 threat through risk communication within communities and private sector engagement. After extensive desktop research, questionnaires, interviews, and risk analyses, we have been conducting COVID-19 risk mitigation training sessions for healthcare workers and management to implement and communicate within their organizations and beyond.

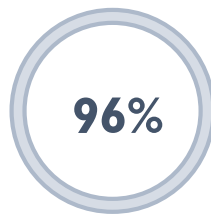
